8. HOTEL RESERVATIONS

USDEC reserved a block of hotel rooms at the InterContinental Singapore, the conference venue. USDEC will not be able to assist with reservations at other hotels. A discounted rate of SGD 335 (approx. USD 268) per night for single occupancy and SGD 365 (approx. USD 292) for double occupancy has been arranged for stays between April 12-21, 2015. This is a 25% savings over regular rates. This rate excludes local taxes, charges and fees, but does include buffet breakfast and broadband internet access. Lodging costs are the responsibility of the participant.

Room reservations at the InterContinental are limited and available on a first-come, first-served basis. **Rooms at the discounted rate are available until March 16 or until the room block is filled, whichever comes first.** We encourage you to make reservations early. The hotel change and cancellation policy is different due to the nature of the discounted room block reservations: you have up until 2 weeks prior to your arrival date to make any changes or cancellations, after that time you will be responsible for the full charge of the reservation.
